PERSONAL GIVING

Rotary clubs around the world raise funds to contribute to The Rotary Foundation. Individual Rotarians are also encouraged to make The Rotary Foundation their 'charity of choice' by making an annual personal contribution. When you give to The Rotary Foundation you support Rotary's work across the world and help ensure our future. You can choose where to direct your donation and how you wish to give. Recognition is offered at many giving levels.

POLIO PLUS

Rotary, working with partners in the Global Polio Eradication Initiative has reduced polio cases by 99% worldwide since our first project to vaccinate children in the Philippines in 1979. Rotarians have helped immunize more than two billion children against polio in



122 countries. Contributions to Polio Plus go straight to work and for as little as 75c, a child can be protected against this crippling disease. We are close to eradicating polio, and The Rotary Foundation is focused on continuing to raise funds for this critical project.

ANNUAL FUND

Contributions to the Annual Fund of The Rotary Foundation are invested for a period of three years to support the running of the Foundation, before being made available to Rotary clubs and districts as global grants or district grants to undertake humanitarian projects around the world.

ENDOWMENT FUND

Contributions to The Rotary Foundation Endowment Fund are invested in perpetuity. A portion of the available earnings are used to supplement Foundation activities and provide grants.

GIVING RECOGNITION





Centurions commit to making an annual contribution of NZ\$100 every year. Rotarians making a contribution of US\$100 are recognized as a **Sustaining Member**.



Every US\$1,000 contributed by an individual to The Rotary Foundation results in recognition with a Paul Harris Fellow. **Paul Harris Society** members commit to making a contribution of US\$1,000 every year.



Rotarians are recognized as a **Major Donor** when their contributions total US\$10,000, and at a number of further levels after that.



Benefactors (US\$1,000) and **Bequest Society** (US\$10,000 or more) members commit to making a contribution to The Rotary Foundation Endowment Fund from their estate.
